- ◆ to represent and coordinate the interest of the Association's members; as part of this, in particular
 - to conciliate their interests;
 - to undertake representation in front of the financial institution utilising the agency activities and in front of the Hungarian Financial Supervisory Authority performing supervisory tasks;

HISTORY

The Association was founded by 13 money-changer companies having dominant turnover. The member of the Association can be any private or legal person who or which complies with the conditions applicable to credit and loan operations set out in Article 3, paragraph (1), item b), as well as for intermediation of financial services set out in Article 3, paragraph (1), item h) of Act CXII of 1996 on Credit Institutions and Financial Enterprises; in particular to the conditions stipulated by the prevailing Government Decree on Money Exchange Services or by a higher level regulation, currently Article 3, paragraph (1) and Article 5 of Government Decree 297/2001. (XII. 27).

The members of the Association operate more than 400 exchange offices in Hungary, employ about 1500 people and are significant players on the labour market. Many of its former staff members are successful employees in other fields of the financial services sector. Its member organisations employ significant number of graduates. Their exchange offices are present in large shopping centres of the country as well as in all towns of county rank. In the coming years, the founders aim to expand quality services in small and medium sized towns of Hungary, as well as to enhance professional reputation of the money exchange activity.

- to undertake interest representation regarding the issues affecting the activities of exchange companies, creditors and money lenders in front of the government agencies entitled to issue legal regulations;
 - ◆ to protect reputation of the money exchange profession;
 - ◆ upon request giving opinion on regulations applicable to exchange companies mediating financial services;
 - ◆ to provide forum for discussion of professional matters, for development of common position and discussion of methodological issues;
 - ◆ to provide training, development of skills, education for money changers, regular information flow on the laws affecting the Association's members;
 - ◆ consumer protection, initiation of actions at the Hungarian Financial Supervisory Authority against major intermediators that violate laws on money exchange or granting of credit and loan;
 - ◆ to keep contact and cooperate with other interest representation organisations in the financial sector.
- The Association performs public benefit activities of skill development, education and consumer protection.
